Information and Materials Needed for H-1B Visa Status

Please note: Once you have filled out this form and returned it with the required documents, this process usually takes 21 business days to ready the H1B petition form. Once mailed, it will take 2 to 8 months to receive an H1B approval notice.

6. Proof of current immigration status if in the United States:
 - a. A copy of **passport** (page with photo).
 - b. I-20's (student status), IAP-66 (J-1 status), DS 2019, etc.
 - c. A copy of applicants (and any dependents) **I-94**, front and back (this form is in the passport if all are in the US). If the dependents are not in the USA, no documents are needed – the H-4 visa can be acquired at a US Embassy or the port-of-entry (cost is around \$100, and two passport-type photos for each dependent is required).
 - d. A copy of dependents' passports and any other visa documents (H-4, etc.) if dependents are in the USA.

18. A copy of original offer letter from the department.

19. Date you last entered the U.S. (should be listed on the I-94).

21. Name of city and country through which the applicant will enter the United States if h/she is now outside of the U.S. The beneficiary will need to make an appointment for the H-1 visa at the U.S. consulate or the port of entry (airport) in this city. Please look at the U.S. Department of State website for consulate addresses and instructions.

Copy of each dependents' Visa Information if the dependent is in the US. If they are not in the US, no documents are needed - the H-4 Visa can be acquired at a US Embassy or the port-of-entry with a cost of around \$100. Two passport -type photos are required for each dependent.

Copy of Social Security Card for dependents (if in the US)
