NOTICE OF FILING

An application concerning the employment of an alien worker for the following permanent position will be filed with the U.S. Department of Labor. This Notice of Filing will be posted for at least 10 consecutive business days, ending between 30 and 180 days before filing the permanent labor certification application.

Position: Assistant Professor (Chinese)

Duties: Entry-level position. Teach a variety of lower division and upper division courses in Chinese language and culture; conduct and publish research in topics related to Chinese language and culture; help build Chinese language program and other related programs in the department; advise and mentor undergraduate students; serve in various departmental committees as needed.

Qualifications: Ph.D. in Chinese language/culture or related field completed by August 13, 2018; ability and willingness to teach all levels of Chinese language courses; demonstrated ability to conduct research and publish scholarly research; near-native or native proficiency in Chinese; high level of English proficiency; ability and desire to mentor students; ability to complement, extend, and enrich the current strengths of the department; satisfactory background check per university policy; required skills and publication requirements may be earned during advanced educational studies.

Salary: At least \$60,000 per academic year. (Utah State University will pay or exceed the prevailing wage, as determined by the U.S. Department of Labor.)
